Reservations and Payments: Your deposit of \$700.00, along with a completed registration form must be submitted to reserve your space. **Retreat deposit is "NON-REFUNDABLE" after March 1, 2012.** Retreat balance is due 65 days before retreat date or by May 1, 2012 and is NON-REFUNDABLE after May 1.

NOTE: If you register after May 1, 2012 the full payment is required in order to confirm your space.

The advertised cost for this retreat is based on a minimum group of 10 participants. Should the group final number fall below the minimum, and in order to still conduct the retreat, there may be a slight surcharge, \$75 - \$150 approximately, depending on the final number of the group. You will be notified by March 1, 2012 if we do not have a minimum number registered and a surcharge might need to be added. Payment is due upon notification. Should the retreat fail to achieve enough participation to conduct it, we reserve the right to cancel the program and refund in full any deposits received.

Cancellations and Refunds: Cancellations must be received in writing. Deposits for individual trips cancelled after March 1, 2012 are non refundable. Individual cancellations after May 1, 2012 all payments made are non-refundable.
