Reservations and Payments: Your deposit of \$500.00, along with a completed registration form must be submitted to reserve your space. Final payment must be received 65 days prior to departure or before Aug. 5, 2017..

NOTE: If you register after Aug 5th, the full tour price is required immediately in order to confirm your space.

The advertised cost for this tour is based on a minimum group of 12 guests. Should the final number fall below the minimum, the tour can still be operated, but there may be a slight surcharge, \$50 - \$150, depending on the final group number. You will be notified 65 days before departure if there is to be a surcharge enacted. Payment is due upon notification. Should the trip fail to achieve minimum participation, Journeys of Discovery reserve's the right to cancel the tour and refund in full any deposits received for the land tour costs.

Cancellations and Refunds: Cancellations must be received in writing. Cancellations before Aug 5, 2017 are subject to a non-refundable processing fee of \$150.00. This charge will be in addition to any cancellation charges imposed by airlines, hotels and or ground operators. Cancellation 65 days or less all payments are “non-refundable”.
