Terms and Conditions: I understand that some or all payments made may be forfeited, based on “my” cancellation of this program as detailed within "Trip Terms and Conditions" listed below.

Reservations and Payments: Your deposit of \$1,500.00, along with a completed registration form must be submitted to reserve your space. Gorilla and Chimpanzee tracking permits will be purchased approximately 4 months (Jan. 1, 2013) before the trip date. Final payment is due 90 days before the tour departure date or no later than Feb 10, 2013.

The advertised cost for this tour is based on a minimum group of 7 passengers. Should the final number of passenger's fall below this number, the tour can still be operated, but there could be a cost increase depending on the final number of the group. You will be notified 90 days before departure if there is to be a surcharge enacted. Payment is due upon notification. Should the trip fail to achieve minimum participation, Journeys of Discovery reserves the right to cancel the tour and refund in full any deposits received. You will be notified of this “before” the tracking permits are purchased. **I understand that there is “no guarantee” that we will find the gorillas as they are wild animals and move on a daily basis. I fully understand and agree that the \$1,500.00 deposit is “NON-REFUNDABLE” under any circumstances once the tracking permits have been purchased.**

This will apply if the tour has to be cancelled “for any reason”, by Journeys of Discovery, the Uganda tour operator or if I am unable to participate and cancel myself. Or due to circumstances beyond our control, such as natural disasters, political situations, government rulings, travel advisories or any other reason that would prevent this tour from operating once the permits are obtained.

Cancellations and Refunds: Cancellations must be received in writing. Your deposit will be refunded for individual trips canceled “prior to the gorilla tracking permits being purchased”. You are responsible for any cancellation charges imposed by airlines, hotels and or ground tour operators. Cancellation 90 days or less all payments are “Non-Refundable”.

Trip Cancellation Insurance: the purchase of trip cancellation / emergency medical insurance is strongly advised to protect against unforeseen emergencies that might force you to cancel this tour, non-refundable payments, medical emergencies during the tour and additional travel expenses that may incur before, after, or during the trip.

Not included: Tips to hotel porters, our driver and local guide etc. are expected and your responsibility. International flight airport departure taxes if applicable. Please plan for this and bring additional funds. All items of a personal nature such as laundry, drinks, telephone calls. Any item that is not specifically detailed in the final trip itinerary. Cost of accommodations & associated services for overnights in route, caused by weather, flight schedules, and other unforeseen events are your responsibility. A final trip itinerary with local tour operator and hotel contact information will be provided at least 2 weeks before departure.
